Patient Care Services

CPAA's core commitment is to provide help on emotional, financial and medical fronts to cancer patients and their family. It is an empathetic, reassuring, non-medical presence to support treatment and overall needs of cancer patients. CPAA's dedicated team of social workers and volunteers rises to every need of the patient to make their treatment and medical rehabilitation most effective. The prominent activities that Patient Care team undertakes are:

Financial Aid: Financial aid for cancer treatment is the primary requirement that CPAA fulfills for scores of underprivileged cancer patients. Financial aid is garnered from various donors and trusts and through innovative schemes and by mobilising funds from our online donation gateway.

Medical Aid: CPAA provides free or subsidised medicines and drugs through tie-ups with pharmaceutical companies and local pharmacies. Access to premier Cancer hospitals, doctors and specialists for treatment and second opinions is made possible through our team of volunteers and social workers. We also provide assistance in diagnosis through special investigations, access to blood banks, prosthesis etc.

Counseling and Guidance: Our counseling cells at specialized cancer hospitals are manned by a team of trained volunteers and experienced professional counselors who act as catalysts in making treatment effective. They provide emotional support, help in coping with grief, counsel the patient and care-giver, help with filling in forms, distribute awareness literature, help in finding extended accommodation facilities, advice on hygiene and diet, provide nutritional supplements, clothing and food grains, palliative care, rehabilitation, handicap certificates and other areas of additional help for cancer patients. Patients and care-givers are also attended to at CPAA's offices by the Social workers and counselors.

Adopt a Cancer Patient: *Studies show that 72% of cancer deaths occur due to delays in diagnosis leading to late presentation of the disease.* The need for financial aid for cancer treatment is a very fundamental requirement. Adopt a Cancer Patient is a scheme where needy patients with excellent prognosis are adopted by donors. The donor is updated with quarterly progress reports with an option of meeting the patient. If the patient requires further treatment at the end of the year, an appeal is made to the donor for continued support, which in most cases is readily forthcoming. In addition to the financial assistance towards medical treatment, CPAA helps the patient and family to come to terms with illness, and infuses them with the ability to cope with the cancer, providing support, guidance and counseling. Additionally, assistance is rendered to interpret reports; institutional, hospital and home visits; ancillary services like prosthesis and ambulance; placing the patient and the school going children/siblings in appropriate institutions, and social rehabilitation for the patient.



Education Fund for Patients: *Over 45% cancer affected families face catastrophic expenditures, 25% are pushed below poverty line.* A cancer diagnosis and treatment has an overwhelming effect on family life, including siblings and other family members. The objective of this fund is to provide financial support to cancer patients, their children and young siblings for education that might have been disrupted due to the illness and the subsequent treatment. It covers School, College and/or any Professional courses.

Support Groups: Care and support post cancer treatment is critical. CPAA regularly organises Support groups for patients and caregivers, provides a forum to discuss their experiences, share ideas, and provide emotional support to each other. It also helps to deal with depression or anxiety. Usually a support group is led by a social worker, doctor or counselor with specialised training in moderating group discussions. CPAA's social workers visit patients in hospitals post surgery to caution of post surgery care, chemotherapy, diet and nutrition.

- **CPAA Mumbai Branch:** A Breast Cancer Meet was organised on 6 November 2015 at CPAA's Sumer Kendra office in Mumbai to mark Breast Cancer Awareness month. Lymphodema Specialist and survivor Ms. Mamta Goenka addressed the gathering about post-surgery care. She carefully explained the do's and don'ts post surgery and how to keep fit with regular exercises. She cleared patients' doubts and encouraged them to stay positive and to try and lead a normal life.



- **CPAA New Delhi Branch:** Guided by CPAA's Total Management philosophy, the Delhi branch completed three years of the initiative of forming the Breast Cancer Support Group. Support Group meetings for Breast Cancer Survivors were held through the year at and in collaboration with All India Institute of Medical Sciences (AIIMS), New Delhi. Some of the activities are briefly given below:
 - 13 January 2015: Prof. Sushma Bhatnagar, Head of Palliative Care, IRCH, AIIMS interacted with the patients and addressed the issues of the survivors. She reiterated the importance of exercise, diet and follow ups and cheered the patients by joining them in a singing session thereafter.
 - 13 July 2015: Prof. Anurag Srivastava (Head of Surgery), Prof. Rambha Pandey (Radiotherapy) and Anjali Bhola (Dietician) spoke on post- surgery precautions reiterating the importance of arm exercises.
 - 11 September 2015: A discussion on Psychosocial issues faced by survivors was facilitated by breast cancer surgeon Dr. Anita Dhar and Clinical Psychologist Dr. Savita Sapra. They were joined in by care-givers Ankur Prakash and Vini Bhatnagar sharing their experiences. After these discussions a few survivors entertained the participants with songs and skits. The participants were gifted goody bags by Mrs. Kiran Hukku, Director, CPAA New Delhi branch and were treated to delicious snacks.
 - 28 January 2016: Prof. Rambha Pandey (Radiotherapy, AIIMS). interacted with the participants. CPAA's Rashmi Warty facilitated the discussion by helping the patients open up about their problems and discuss it with the audience.



- 9 March 2016: The successful completion of 4 years of Delhi branch's Breast Cancer Support Group was celebrated on the International Women's Day. On this occasion Prof. Renu Misra, a renowned Gynecologist, the Guest of Honor, spoke on emotional well being of the group members. Dr. Anita Dhar (Surgeon) and Dr. Savita Sapra (Psychologist) addressed women's issues giving them an insight into how to gain confidence to assert themselves in various aspects of their life. The participants enjoyed a round of housie with attractive prizes.

Pediatric Oncology: A playroom is managed by CPAA's social workers at the AIIMS, New Delhi for childhood cancer patients undergoing treatment with their siblings welcome to spend time here. Games and toys are made available to keep them in a happy and stress free environment. The social workers try and involve the children in simple activities like craft, games, reading etc. Special activities are organised on Rose Day, Diwali, Christmas and other important days or festivals. Every Wednesday CPAA, Delhi, distributes food and several items to the patients at the Day Care Unit.

Recreational Room: The Rajgarhia Dharamshala (AIIMS) houses outstation patients undergoing treatment in the city, along with their care-givers. Thrice a week, CPAA organises various recreational activities for the inmates including yoga, arts and crafts, indoor and outdoor games, singing, dancing, education and lectures on hygiene and cleanliness, nutrition, story-telling, drawing and painting and handicraft. Important festivals and National Days are celebrated with great fervor.

Patient Donor Meet: Patient Donor meets are regularly organised by CPAA to develop a connect of the Donor with their beneficiaries. It promotes and maintains transparency with the Donors giving them a first-hand interaction with the patients and their families.

200 beneficiary patients from different hospitals such as Cama, Nair, KEM, Tata, Wadia and Sion were invited to meet the donors from Naraindas Morabi Budharani Trust on 11 March 2015 at Manav Seva Sangh, Mumbai. A Magic show, Juggler

show and a Comedy show was put together to entertain the children. Childhood cancer patients, adopted by the Tata group were invited to meet their chairman and staff on 1 October 2015. The children were treated to a movie and snacks. They were gifted a school bag filled with goodies. Around 150 childhood cancer patients children from different hospitals were invited for a meet with one of our long-standing donors Naraindas Morbai Budhrani Trust on 15 February 2016 at Sion Hospital Auditorium, Mumbai. The event was well attended by doctors from Sion, Wadia and Nair hospitals along with their social workers. Everyone enjoyed the magician's and juggler's show and danced to the foot-tapping music. They were all treated to a sumptuous lunch thereafter.

Moments Of Relief:

CPAA patron Sudha Sharma celebrated her son's birthday on 10 April 2015 in a unique and meaningful way. With her son and a friend in tow she came to the Pediatric wing of Sion Hospital, Mumbai to have a birthday party. Her son cut a cake with the young patients there and distributed goody bags to all. It was indeed an enriching experience for the young birthday boy.



As part of informal educational activities, childhood cancer patients and their siblings were taken to National Rail Museum, New Delhi on 21 April 2015. The Museum officials took the children for joy rides. They were given a guided tour of the display of old coaches and steam locomotive engines, giving an insight of how the railways have changed over the years.



On 22 April 2015, our patron Shaherbanoo Begum organised a toured picnic of the stables of the Mahalakshmi Race Course, Mumbai for childhood cancer patients. They were delighted to see the horses swimming, exercising and training. And as always no picnic could have been complete without a hearty meal.

A summer workshop was organised in the Vishram Sadan Complex, New Delhi, on 30 April 2015 for childhood cancer patients. The young and enthusiastic executives of CIPLA volunteered to guide the kids in the painting activity. Saskia Rao-de Haas, the internationally acclaimed Cello player enthralled the children with her lilting music.

CPAA in collaboration with Shubhendra and Saskia Rao Foundation, conducted an introductory music workshop for childhood cancer patients under palliative care entitled 'Music is the birthright of every child'. Pandit Shubhendra Rao and his team introduced the children to various musical instruments at Sai Hall, Vishram Sadan Complex, New Delhi on 25 May 2015.

The Smile Group, a volunteers' group conducted a workshop for patients and their care-givers in New Delhi on 29 May 2015 at Sai Hall of Vishram Sadan Complex. The program entitled 'The awareness of mind and how to direct its thoughts, beliefs and emotions to be happy' encouraged the participants to think with a positive frame of mind and put a smile on their faces.

The Union Bank of India celebrated the first year anniversary of their ladies wing on 30 May 2015 at their corporate office in Nariman Point, Mumbai. CPAA was one of the three NGO's invited to participate in this event. Childhood cancer survivor's gave a delightful dance performance. The children received gifts as a token of appreciation and were treated to a sumptuous high tea thereafter.



25 childhood cancer patients were invited to attend a special showing of a popular entertainer called 'Clown without Border' at Ravindra Natya Mandir, Mumbai on 11 June 2015. The US based group had



the children in splits throughout the performance. The audience consisted of 100 other children from different NGOs across the city, and took photographs with the adorable clowns as memento of an eventful evening.

On the occasion of Father's Day, a student volunteer, Snehal Bindra conducted a card making workshop for the beneficiaries of CPAA-GCF project in the playroom at AIIMS, New Delhi, on 19

June 2015. The children enthusiastically made special cards for their fathers.

A group of childhood cancer patient beneficiaries of the CPAA-GCF project were taken to Shanker's International Doll Museum, New Delhi on 30 June 2015. The display of authentic Indian costume dolls of every state and the dolls from other western countries were a visual treat.

15 childhood cancer patients were treated to a fun-filled morning at Kidzania, Mumbai an indoor theme park for families, on 19 July 2015. It aims to educate and entertain children through role-playing activities. The outing for the children was graciously sponsored by Mr. Vinay Hariharan and Sanjeev Chadha from Balaji Group. The children were treated with delicious breakfast and lunch.



CPAA's volunteers Preeti Gupta and Louis Ten Bosch of UK conducted a Crafts Workshop at Day Care ward AIIMS, New Delhi's for children undergoing chemotherapy, on 24 July 2015. The children enjoyed making and tying friendship bands along with other crafts for Friendship Day. The activity proved relaxing as well as therapeutic for them.

The childhood cancer patient beneficiaries of the CPAA-GCF Project had a field day at a 'Photography Workshop' on 4 August 2015 at the National Balbhavan, New Delhi. The children had a hands-on experience with antique as well as digital cameras. They were taken to an actual studio and shown different lighting techniques. The kids were most excited when given an opportunity

Rehabilitation

CPAA's Rehabilitation Centre was initiated in 1987 with the objective of restoring confidence in the lives of cancer survivors by helping them find the ability to support themselves. They are trained in various crafts to enable them employment post treatment. During the training period, patients or their family members are given a monthly wage, conveyance expenses, children's school fees, medical aid and rations from the food bank. Over 26,000 cancer patients and their family members have been supported. Corporate orders from reputed organisations and regular customers at the CPAA's Gift Shop encourages the enterprise.

The Rehabilitation Centre of CPAA plays an important role of putting a smile back on the faces of cancer patients. Once the disease is defeated, rehabilitation takes centre stage. Today, cancer does not mean total impoverishment of the whole family, as can be seen by the 90 workers that are employed at any given time by the Rehabilitation Centre. They all manage their daily life chores with a lot less stress and a lot more means!

Cancer Awareness & Prevention

In India, the most common cancers are oral cancers in men, and cervical and breast cancer in women. These cancers are curable if detected at an early stage and cervical cancer is preventable. It is hence imperative that people be educated regarding cancer in order to prevent it or detect it at a precancerous stage. This triggered CPAA's efforts to raise awareness and promote early detection.

CPAA conducts awareness programmes at schools, colleges, factories, hotels, residential localities and offices, emphasising the correlation between tobacco usage and oral and lung cancers; and infections with high-risk Human Papilloma Viruses and cervical cancer. The lectures and open forum programmes are reinforced by targeted brochures, posters and educational literature.

Information: CPAA compiles and creates informative cancer brochures, to understand and a quick reference guide to patients, caregivers including laymen. Brochures on Breast cancer, Cervical cancer, Diet and Cancer, Leukemia, Lymphedema, Lung cancer, Ovarian cancer, Tobacco related Oral/Lung cancers, Prostate cancer, Testicular cancer, Chemotherapy and Radiation are provided in English, Hindi, Marathi and Bengali languages at various hospital and treatment centers. The brochures elaborate on symptoms, risk factors, treatment options etc and are endorsed and approved by concerned expert oncologists. CPAA's 'Sahayata' is a quick reference resource handbook containing contacts of community help and welfare services pertaining to cancer-related issues.

Infomercials And Short Films: Over the years several advertising agencies and publishing houses have come forward to help us raise awareness about critical issues pertaining to tobacco consumption and cancer in general by creating short films, infomercials and posters. The efforts have won us several awards and accolades worldwide, and have thus signaled the organisation's seriousness in dealing with tobacco issues and policies. Lectures And Open Forums : CPAA's cancer awareness lectures educate about the correlation between lifestyles and cancer. Lectures are given in English or a local regional language at schools, colleges, factories, hotels, residential localities and offices. Cancer is explained with the help of pertinent presentations giving facts about risk factors, myths, specific cancers - early signs / symptoms, statistics of prevalence and prevention, posters and brochures to portray a realistic picture about cancer and help remove the perceived stigma.



Efforts are made to reach areas and groups that are inaccessible or unapproachable. Target groups are School and College students for awareness of the ill-effects of Tobacco; Women's groups for Breast and Cervical cancer awareness; inmates of Jails/Prisons; Personnel and families of the Armed forces; blue-collar workers etc. The message is reinforced in innovative ways like skits, surveys, posters, drawing or slogan writing competitions, mass pledges. Special programs are

organised to mark events like World Cancer Day, International Womens' Day, International Womens' Day, Breast Cancer Awareness Month, etc

- 15 major awareness drives were organised by the Mumbai team in English, Hindi and Marathi to cover about 2,000 people at the National Association for the Blind; Barister Nath Pai Sevangan, Malvan; Red Cross Society, Silvassa; Lions International School; Imphal, Manipur; MLIRC, Belgaum; Gram Panchayat Hall, Silvassa; Government School, Vapi ; villages of Barthu, Bandhuganj, Hulasganj, Ghoshi, Ginjiar and Sonma in Bihar and Asalfa village, Ghatkopar. Tobacco Cessation Program- 'Quit Tobacco For Life': Today's laws have made it mandatory for corporates to enforce a tobacco free workplace. However, CPAA believes that it is in the employer's interest to help employees to quit voluntarily rather than have it forced upon them. Smoking has an adverse effect on your employees' health and results in loss of productivity; hence the use of effective workplace smoking cessation initiatives will result in measurable benefits in terms of health, social and economic gains. CPAA's Tobacco Free Workplace program starts with an awareness lecture to explain the dangers of smoking, causal relationship with cancer and strategies used by the tobacco industry to promote addiction. The information is related in a scientific, non threatening manner, providing education on the deleterious effects of tobacco on health, benefits of quitting and providing motivation. Introductory training on Tobacco cessation is imparted to the employee population per se without segregating tobacco users. Users are invited to contact us through email, mobile or personal visit to our office at Mumbai, directly or through their HR department.

Studies show that 72% of cancer deaths occur due to delays in diagnosis leading to late presentation of the disease. Top 5 cancers account for 47.2% of the total cancers and can be detected early with better prognosis and cure rates and lower mortality rates.

CPAA runs a diagnostic clinic and pathology lab at Naigaon, Mumbai, and a state-of-the-art Polymerase Chain Reaction (PCR) based Human Papilloma Virus detection laboratory at Mahalaxmi, Mumbai. Free cancer screening clinics are conducted at Naigaon once a week and on-site at subsidised rates in Mumbai, New Delhi, Pune and throughout India.

300 Cancer Screening and Early Detection Camps and Clinics were organised by the Mumbai team to cover over 15,000 healthy / high risk individuals from a cross section of the society to include: Various community groups, social service organisations, churches, underprivileged groups, families in residential localities, corporates, blue-collared workers, teachers and parents at schools and colleges, and the staff and families of civil services and armed forces. The Mumbai team also brought cancer screening facility to the villages of Barthu, Bandhuganj, Hulasganj, Ghoshi, Ginjjar and Sonma in Bihar. These programs were organised by CPAA in association with individual groups and General Insurance Corporation Of India, Mahindra & Mahindra Ltd, Universal Comfort Products Limited, HPCL, Tata Realty & Infrastructure Ltd, Oriental Insurance Company. Additionally, 56 free clinics were organised in-house and requisite follow-up procedures were followed. 1,420 women were tested for HPV at our (PCR) based Human Papilloma Virus (HPV) DNA laboratory at Mahalaxmi, Mumbai.

Cancer Insurance

39 million Indians have zero or negligible government or insurance-sponsored healthcare cover.

In India today, there are currently 3 million cancer patients and around 1.1 million new cases are recorded annually. Over 60% of the cancer patients present themselves in advanced stages of the disease with 20% cure rates. The most common cancers found in our country, in males are oral and lung cancer and cancers of the cervix and breast in women. All of these can be detected at early stages with detectable precancerous lesions in cervical cancer. Keeping this in mind CPAA and the New India Assurance Company jointly launched a Cancer Insurance Policy in 1994 for healthy individuals to secure their financial future against potential health risks, and ensure funding for cancer treatment. To date we have over 12,000 policy holders and 994 of the insured individuals have been given claim benefits to the tune of Rs. 6.23 crores.

After a clearing mandatory cancer screening at CPAA's Cancer Detection Centers with no cost to the individual, person is enrolled for the policy as per their choice. The policy takes effect 180 days from the date of the medical check-up. A policy holder if diagnosed later with cancer, is eligible to reimbursement of expenses for treatment, hospitalisation, investigations related to cancer as specified in the policy document up to the insured amount, each year against bills submitted, until the patient is cured or succumbs to the disease upto the tune of Rs. 2 lakh per year. A one-time payment of Rs. 8,000 provides cancer insurance for 15 years. The Policy holder is also eligible to a free annual screening in the insured period.

The policy has several unique benefits. If an individual is subsequently diagnosed with cancer, reimbursement of expenses for treatment, hospitalisation, investigations related to cancer as specified in the policy document up to the insured amount, will be made each year against bills submitted, until the patient is considered cured or succumbs to the disease. All treatment has to be taken in India and must be allopathic in nature.

- **Single Nucleotide Polymorphisms as Predictive Diagnostic Biomarkers in Oral Cancer:**

Dr Dhananjaya Saranath, Dr Sultan Pradhan, Neeta More.

Oral cancer is a high incidence cancer in India and bears 26% of the global cancer burden as collated and analyzed by the International Agency of Cancer Research, Lyon, France from 187 countries. The current project was initiated to understand why only a small proportion of high risk individuals with life style habits such as long term consumption of tobacco, areca-nut, alcohol and infection with a high - risk Virus type – Human Papilloma Virus type 16/18, develop oral cancer. Variations in the genome of the individual may reflect high risk of development and progression of oral cancer. The project will examine the differences in the genome of oral cancer patients and individuals with long term tobacco habit and no oral cancer. The project is anticipated to be completed by 2017.

Twinning Project: CPAA's UICC funded Twinning Project was launched in 2010. To share learnings of the past years, in particular, the philosophy of Total Management of Cancer, CPAA identified NGOs, one each from the Indian states, working in the field of cancer. The project put them in touch with one another and shared CPAA's information material in the form of brochures, leaflets, CDs, booklets and stickers in regional languages. During the past year professionals from NGOs all over India have participated in this programme. This programme empowered them with the Total Management philosophy of CPAA to assist them in taking their work forward more effectively. Participating NGOs in 2015-16:

Mumbai: Participants from Triveni Young Blood Foundation, Hoogly, West Bengal, were invited to CPAA's Mumbai office as a part of its Capacity Building Twinning Project under the aegis of UICC, from 13 - 17 July 2015. While this organisation already runs an orphanage and a school, they have now taken up the project of cancer care, awareness and treatment facilities in their region. The participants attended several presentations and had meetings and discussions with all the activity and departmental heads at CPAA. They were eager to implement their learning's, back home. CPAA also welcomed delegates from Tribhuvan Sevak Cancer Trust, Azamgarh, UP, in October 2015

Volunteer Training Workshop: CPAA runs a 3 day 'Psycho-Oncology Volunteers Training Programme' to educate individuals working in the field, imparting basic information regarding cancer, highlighting psychological, social and medical problems faced, and help patients and family members cope with cancer. The programme was originally developed and put together by a qualified counseling psychologist, Ms. Meghana Suchak. The program has evolved with our experience over the

years. The programme has run successfully for the past four years and over 500 volunteers have benefited from the programme. The programme is of use to anyone working in the field of cancer including employees of healthcare institutions, pharma companies and medical equipment manufacturers as well as CSR departments of corporates.

The workshop aims to initiate participants into the CPAA approach to volunteering and counseling. It provides basic information and knowledge about cancer and its treatment. However, the larger aim is to help participants understand universality of grief and loss, and the ability to deal with cancer.

Apart from the monthly workshops, exclusive workshops were organised for select groups all over the country. Currently, Dr. Veena Shukla coordinates the workshop, with Ms. Susmita Mitra and Dr. Dhananjaya Saranath as the core faculty.

WORLD NO TOBACCO DAY:

Every year, on 31 May, World Health Organisation (WHO) and partners mark World No Tobacco Day,



highlighting the health risks associated with tobacco use and advocating for effective policies to reduce tobacco consumption. This year they urged countries to work together to end the illicit trade of tobacco products. The illicit trade of tobacco products is a major global concern, including health, legal and economic, governance and corruption. CPAA took various initiatives to spread this message whilst keeping intact the core message of educating people on the ill-effects of

tobacco products.

Mumbai: Our study conducted in 2014, to estimate the prevalence of tobacco use among police personnel in Mumbai revealed that almost 70% of police staff consume tobacco, with a significant association observed between consumption of tobacco and occurrence of cancer and precancerous lesions. Periodic oral health examination and health promotion strategies to sensitize the individuals have played a key role in them refraining from these flavored addictive carcinogens. To encourage police officers who occupy an important position in the community both as law enforcers as well as role models, CPAA launched its Tobacco Free Mumbai Police campaign on 22 May 2015 at the Azad Maidan Police Club. Senior Police Officers present on the occasion were Dr P S Pasricha (Ex-

Commissioner of Mumbai Police); Mr. Deven Bharti (Joint CP, Law and Order); Mr. Anup Kumar Singh (Joint CP, Admin) and Mr. Atulchandra Kulkarni (Joint CP, Crime). Ms. Vineet Gill Munish represented WHO India and actors Raveena Tandon Thadani and Vivek Oberoi were the chief guests along-with

While several cases of chewing tobacco, smoking and poor oral hygiene were identified, 13 of them were suspected with precancerous lesions such as leukoplakia, sub mucous fibrosis, melonoplakia and difficulty in swallowing and opening of mouth. All inmates were counseled and guided appropriately.
