**MEMORANDUM OF ASSOCIATION**  
**of**  
**CANCER PATIENTS AID ASSOCIATION**  
**P.T.R. No. F-1894 (Mumbai)**

**1. TITLE: -**

The society will be called "CANCER PATIENTS AID ASSOCIATION, MUMBAI"

**2. LOCATION: -**

The Registered officer of the Association shall be located at Unit no.6,  
Sumer Kendra, Behind Mahindra Towers, Shivram Seth Amrutwar Road,  
Worli, Mumbai – 400 018

**3. AIMS & OBJECTS: -**

The Aims & Objects of the Association shall be as follows: -

- a) To provide financial aid for treatment of needy patients suffering from cancer;
- b) To provide aid in the form of drugs, blood artificial limbs or any other aid essential as recommended by medical specialists to the needy cancer patients;
- c) To provide nursing and ambulance facilities to the poor cancer patients;
- d) To build and run a general hospital for the poor including specialized facilities for the diagnosis and treatment of cancer.
- e) To build a lying-in-hospital for the terminal cases of cancer,
- f) To establish facilities for conducting research in the treatment of cancer;
- g) To establish a center for the rehabilitation of cancer patients physically, emotionally and socially.
- h) To conduct various cancer awareness and detection camps throughout the country and overseas about Cancer
- i) To provide training facilities to medical, scientific and other technical staff working with the Association.
- j) To publish books and periodicals regarding the Association's work and any other matters related to Cancer.
- k) To maintain close association and co-operation among individuals and institutions devoted to alleviation of those suffering from Cancer.
- l) To seek affiliation with national and international institutions or societies formed for promoting its objects.



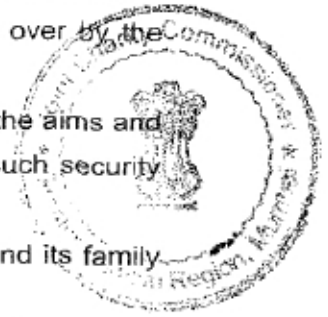

- m) To acquire, purchase, take on lease or in exchange, hire or otherwise acquire any movable or immovable property of any tenure or description and any estate or interest therein and any rights or privileges which the Association may think necessary or convenient for the promotion of its objects and to construct, maintain and alter any building or erections necessary or convenient for the work of the Association.
- n) To sell, let, lease, mortgage, gift, dispose or, manage, develop, build or alter all or any of the property or assets of the Association as may be thought expedient with a view to the promotion of its objects.
- o) To receive and accept donations, gifts, grants or contributions in cash or kind from any person or persons, organisation, Association, company, authority or Government for the furtherance of the aims and objects of the Association and upon such terms and conditions as the Association in its absolute discretion may think fit.
- p) To raise funds for the cancer patients by conducting various events / shows.
- q) To engage, employ and remunerate persons for carrying on the work of the Association on such terms and conditions as may be determined from time to time.
- r) To receive, undertake and execute any trusts and to take over institutions which may lawfully be undertaken and taken over by the Association and may be conducive to its objects.
- s) To borrow or raise money for the purpose of carrying out the aims and objects of the Association on such terms and by giving such security as may be determined from time to time.
- t) To sponsor education to patients suffering from cancer and its family members.
- u) To provide food grain and any other such necessities to the patients and its family.
- v) To give donation (other than donation for corpus) to any other charitable trust/organization to carry out their charitable objects and for helping poor and needy people.
- w) To conduct all activities incidental or ancillary to the attainment of the above-mentioned objectives.
- x) To apply the income of the trust for "the advancement of any other object of general public utility as the Executive committee may in their absolute discretion deem fit and in such a way as they may consider most advantageous to the recipients.
